- Vacation Rental was always included, BUT the Individually advertised units supplement started in 2014
- Individually advertised unit Data was added due to the evolving segment of vacation rentals, including data on pricing and geographical location of the supply

The total number of units in the State of Hawai'i Visitor Plant Inventory for 2018 was 80,751 visitor units, 0.1 percent higher than in 2017 [Figure 2].

- Nearly half (48.4 percent) of the state's visitor units were located on O'ahu, with the majority of units located in Waikīkī. Maui had the second most units (26.5 percent) followed by Hawai'i Island (13.4 percent) and Kaua'i (11.2 percent). Moloka'i and Lāna'i had the fewest lodging units and combined totaled less than one percent of all Hawai'i lodging units.
- A large majority of the lodging supply in the state was made up by Hotel units (54.3 percent). Vacation Rentals, Timeshares, and Condominium Hotels accounted for 16.2 percent, 14.8, and 13.1 percent of all lodging units, respectively.

- 2014 HTA reported <u>7,162</u> officially reported vacation rental units (22,238 individually advertised units)
- 2015 HTA reported <u>10,942</u> officially reported vacation rental units (**27,177** individually advertised units)
  - Use 17,000
- 2016 HTA reported <u>10,918</u> officially reported vacation rental units (**32,565** individually advertised units)
  - Use 20,000
- 2017 HTA reported <u>12,659</u> officially reported vacation rental units (**38,100** individually advertised units)
  - Use 23,742
